If you care to consider your Standing Orders, Financial Regulations etc, you will see that these documents are done on a monthly basis for the councillors.
- 3. Not only have you not supplied payment schedules, you have not supplied any information at all for October 2024, and December 2024.
- 4. As I have already explained, the parish council's website is archived at regular intervals and this is the council's website on 9th December 2024 you will notice the lack of the documents that you are claiming are published on your website.
